### **Tradition**

The Společnost pro ranou péči (Association for Early Intervention) is a non-governmental organisation that provides services, support and help to families with visually impaired and multiple disabled children since 1990.

### **Activities**

The main aim of the organisation is to provide field (mobile) services to families with disabled children in their natural (home) environment through 6 centres in 10 regions of the Czech Republic.

### **Mission**

We provide support and help to families of children at risk of development or disability to better manage their lives.



### **Aims**

Children with disabilities or at risk of development at an early age are provided with sufficient support for their family development and professional services at home.

Parents (carers) of children with disabilities or at risk of development have timely information, support and professional help.

Parents (carers) feel competent in educating and supporting the development of a child with disabilities or at risk of development.

Parents (carers) of children with disabilities or at risk of development are partners of the professionals: they take part in deciding on the necessary support and services for themselves and their child.

The public, professionals and communities are aware that children with disabilities have the right to grow up in a family and the family therefore needs the support of society.

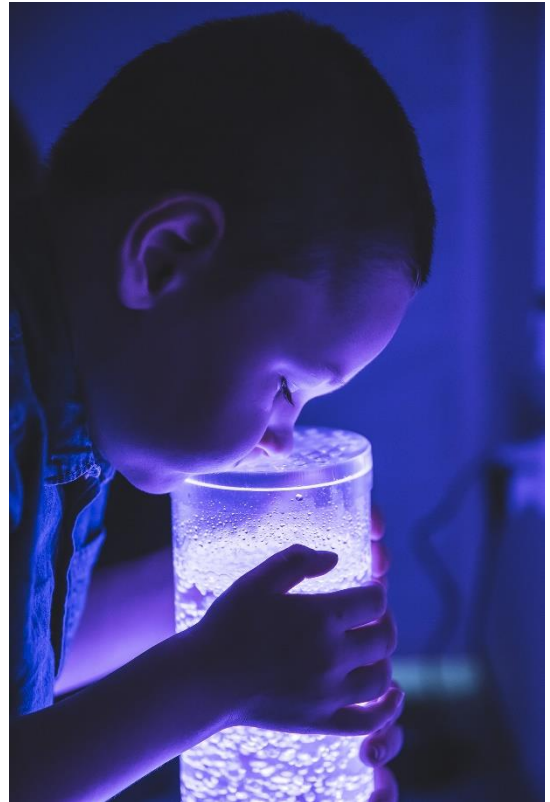
## **Clients and services**

The services are intended for:

- families with visually impaired and visually-combined disabled children from their birth till 7 years of age
- families with children at risk in visual scanning because of visual impairments from their birth till 7 years of age

Some offices provide additional services for:

- families with a physical disability, learning difficulty, and multiple disabled children, including children with PAS from birth to 7 years of age
- families who have become foster parents
- families who care or are preparing to care for a child who is at risk of development. (A child at risk of development means a child who is at risk in their physiological and social development. The development is at risk because of an unsuitable environment.)

## **Types of services:**

### Field (mobile) services:

- regular consultations with families – the major activity within our services
- early intervention consultants regularly visit families and provide support and guidance
- regular consultations include direct work with a child, counselling their education, use of didactical devices, social counselling, support in terms of active learning, communication and other activities depending on the individual requirements of the family
- provide accompaniment to a family while visiting doctors, government offices and pre-school facilities
- loaning out suitable devices and toys
- arrangement of contacts to other professionals
- provide contacts with other families in a similar situation

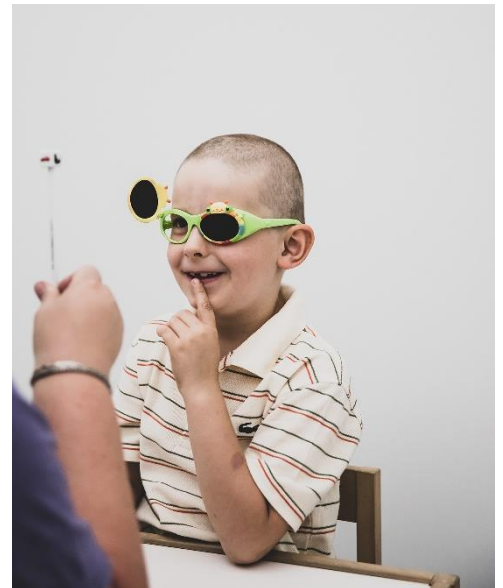


Outpatient services - are held within our centres:

- functional vision assessment – evaluation of a child's current level of visual functions using special tests and techniques
- outpatient consultations focusing on the child's visual stimulation and visual training
